• **EXHIBITOR AGREEMENT**

ARTIST, YOU HAVE BEEN INVITED TO EXHIBIT YOUR WORK WITHIN THE GUIDELINES OF THIS AGREEMENT. IF YOU FEEL THAT YOU CANNOT ADHERE TO THE FOLLOWING GUIDELINES THEN DO NOT SIGN.

- 1) RESIDENCY** -THE WORK I WILL DISPLAY IS MY WORK AND I HAVE FULL TIME RESIDENCY IN THE INNERBANKS AS DESIGNATED ON WWW.IBXARTS.ORG.
- 2) MARKET** -I WILL NOT MARKET, SOLICIT OR DISPLAY ART THAT DOES NOT DEPICT THE SPIRIT OF THE INNER BANKS AND/OR WAS NOT CREATED BY MYSELF OR FAMILY MEMBER THAT RESIDE WITHIN THE REGION.
- 3) ART** -MY WORK WILL NOT DEPICT LUDE REPRESENTATIONS, NUDITY, VULGAR IMAGERY, OR CONTAIN ANYTHING OBJECTIONABLE TO THE DIRECTORSHIP OF IBXARTS. I UNDERSTAND THIS IS SUBJECTIVE AND IS AT THE DISCRETION OF IBXARTS DIRECTORSHIP. (IF IN QUESTION PLEASE CONTACT BEFORE SIGNING 252 796 5665, WE WILL CLEAR ANY WORK PRIOR TO THIS AGREEMENT)
- 4)PROVISIONS** - I WILL NOT ARGUE OR BE CONTENTIOUS ABOUT BOOTH AVAILABILITY, PLACEMENT, OR PROVISIONS, FURTHERMORE, I UNDERSTAND THAT IBXARTS HAS DONE IT'S UPMOST TO PROVIDE A FAIR OPPORTUNITY TO PROVIDE AN EXPENSE FREE SPACE TO EXHIBIT.
- 5) TAXES** - I UNDERSTAND THAT I AM SOLEY RESPONSIBLE FOR ANY AND ALL TAX LIABILITY AS A RESULT IN SELLING MY WORK. TAX INFORMATION AND COLLECTION IS NOT THE DUTY OF IBXARTS

• **MEDIA RELEASE**

IBXARTS CAN USE OR RELEASE TO PARTNERED ENTITIES ANY IMAGES TAKEN DURING THE ARTSFEST FOR THE PURPOSE OF PROMOTION OR PRESENTATION OF AN ARTISTIC ECONOMY IN THE INNER BANKS OF NC. EVERY EFFORT TOWARDS PROPER CREDIT WILL BE TAKEN BUT NOT ASSURED.

• **LIABILITY WAIVER** IF I AM ASKED TO LEAVE THE PREMISES DUE TO CONDUCT, OR REPRESENTATION THAT THE DIRECTORSHIP DEEMS INAPROPRIATE I WILL REMOVE MY PROPERTY AND EXIT WITHOUT INCIDENT REGARDLESS AND WILL SHOW RESPECT THE DESCISION OF IBXARTS.
